It is intended that part of the proceeds of this credit will be applied to eligible payments under the contract for “**Refurbishment Works for Establishment of Data Center (Civil, Furniture, Electrical, HVAC, Security and Networking) at Rawalpindi**”

2. The Project Director-PIFRA, department of the Auditor General of Pakistan, now invites **Sealed Bids** from eligible bidders for procurement of the above work.

A complete set of bidding documents may be purchased by interested bidders on submission of a written application to the address given below and upon payment of a non-refundable fee of Rs. 1000/- in the shape of CDR/Pay Order/Bank Draft in favor of **Project Director PIFRA, Islamabad**. The provisions in the ‘Instructions to Bidders’ and in the ‘General Conditions of Contract’ are the provisions of the World Bank **Standard Bidding Documents for Procurement of Works for National Competitive Bidding, Pakistan**.
4. The completion period for the work is **Six (06) Months**.
5. Bids must be delivered to the above office on or before **04-04-2014** (12:00 noon) and must be accompanied by a bid security of 02 % of the total bid price. **Electronic bidding is not allowed**. Late bids shall be rejected. Bids will be opened in the presence of bidders’ representatives who choose to be present on the occasion on **04-04-2014** at 12:30 am in Committee Room-PIFRA Directorate, Islamabad.
6. A pre-bid meeting will be held in the Committee Room of PIFRA Directorate, Islamabad on **27-03-2014** at 11.00 am at the address given below. The bidders are required to submit their queries in writing at least seven (07) days before the date of pre-bid meeting.

The Project Director-PIFRA reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids at any time prior to award of contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the grounds for the purchaser’s action.
